

Global Growth Portfolio

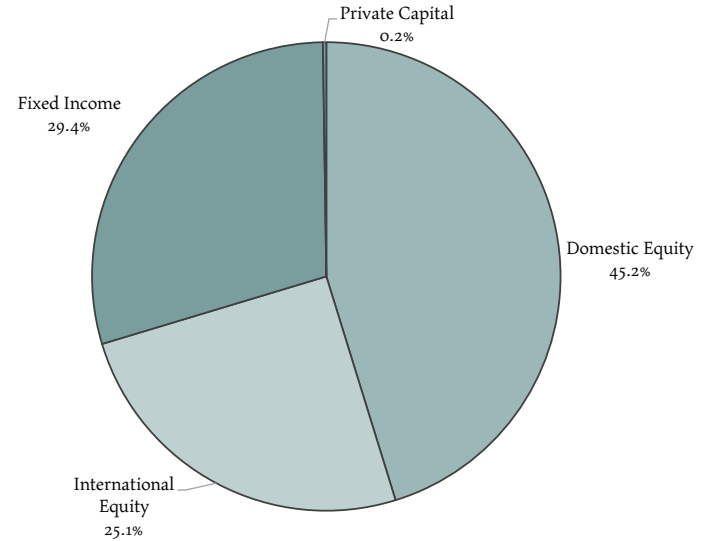
The Global Growth Portfolio's total return net of all investment management related fees over the past twelve months was 24.8%, which trailed the Global Growth Target Return by 0.7%. Over the past ten years, the Global Growth Portfolio trailed its target by 0.2%, net of all investment management fees.

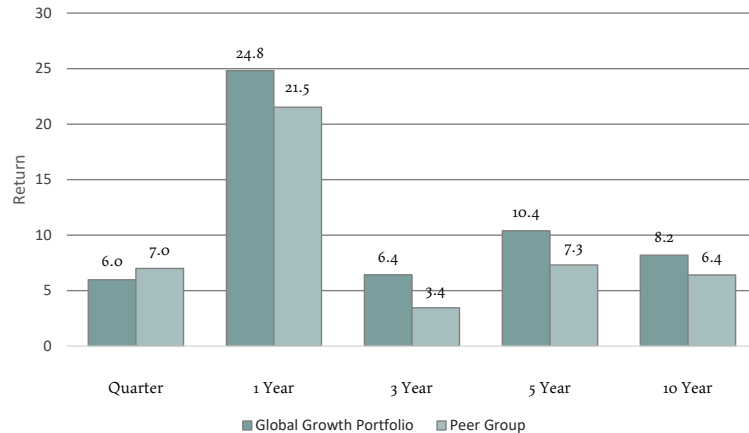
