Short-Term Portfolio

The Short-Term Portfolio's total return net of all investment management related fees over the past twelve months was 4.8%, which trailed the Short-Term Target Return of 5.5%. Over the past ten years, the Short-Term Portfolio trailed its target by 0.3%, net of all investment management fees.


