The Intermediate-Term Portfolio's total return net of all investment management related fees over the past twelve months was 13.4%, which led the Intermediate-Term Target by 0.3%. Over the past ten years, the Intermediate-Term Portfolio matched its target return, net of all investment management fees.



Maintaining diversification through investing in a mix of assets (stocks, bonds, and cash) is an important part of achieving our long-term return objectives.


We utilize broadly-diversified, low-cost index solutions to gain access to most capital markets.
