The Bank of America Agency Portfolio's total return net of all investment management related fees over the past twelve months was 6.3%, which trailed the target benchmark by 0.1%. Over the past ten years, the Bank of America Agency Portfolio trailed its target by 0.5%, net of all investment management fees.

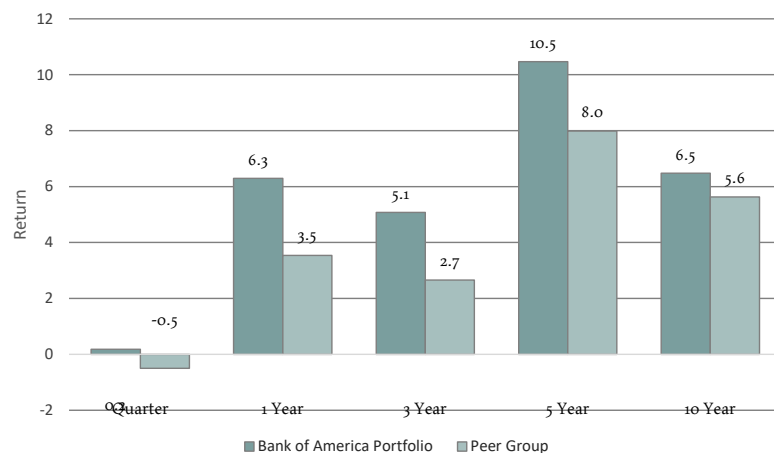

We utilize broadly-diversified, low-cost index solutions to gain access to most capital markets.

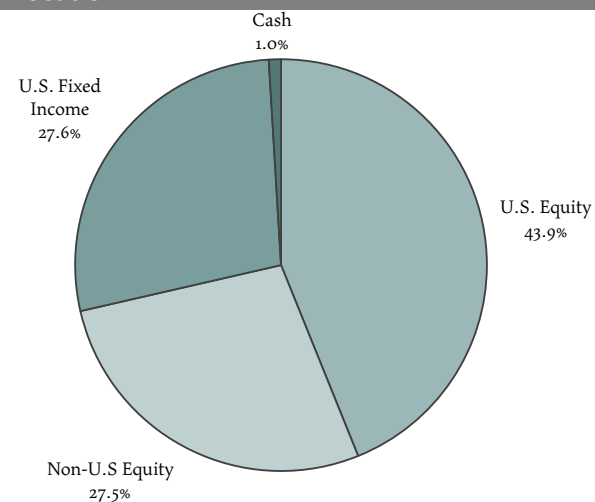
